REGULATIONS

The final text of these Supplementary Regulations shall be the English version, which shall be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 1 – Organisation

The Competition, which has the status of an International Competition, shall be run in conformity with:

- the FIA International Sporting Code ("the Code") and its Appendices,
- the National Sporting Code (SAMŠ and PZM),
- the official FIA Bulletins,
- the General Prescriptions applicable to International Hill Climb Competitions,
- the SAMS Sporting regulations of the Hill Climb races and
- these Supplementary Regulations.

Competition counts towards the following Championships:

- FIA Historic Hill Climb Championship (HHCC) Round 2 according special Suppl. Regulations
- FIA International Hill Climb Cup (IHCC) Round 2 according special Supplementary Regulations
- Slovak Hill Climb Championship (MSR) Round 4 and 5
- Slovak Historic Hill-Climb Championship (MSR HA) Round 2 and 3
- Polish Hill Climb Championship (GSMP) Round 3 and 4
- Slovak Hill-Climb Cup (SKP) Round 1 and 2
- Slovak Trophy Historic Regularity Hill Climb (ST HP) Round 1 and 2 (details described in the Appendix 2 of these Supplementary regulations

Article 3 - Eligible vehicles - Groups and Categories

3.1 MSR:

3.1.1 Vehicles which comply with FIA Appendix J respectively with SAMŠ national technical prescriptions are eligible to take part:

Group A - including R2, R3, R4, R5, WRC, Kit Car, S1600, S20, NA

Group E1 - including GT, SP, F, E1/SK

Category II: Group E2-SH

Group D/E2 (D/E2-SS, CN/E2-SC) - including NF 1000

3.1.2 Cars will be divided up into the following cylinder capacity classes:

-2000 cm³, +2000 cm³ Group N: -1400 cm³, -1600 cm³, -2000 cm³. +2000 cm³ Group A: -2000 cm³, -1400 cm³, Group E1: -1600 cm³, +2000 cm³ -2000 cm³, -1000 cm³, +2000 cm³ Group D/E2: Group E2-SH: -2000 cm³, +2000 cm³

3.2 MSR HA:

Vehicles must comply with Appendix K, Appendix J FIA ISC and NTP (National technical prescriptions) of SAMŠ. They must have valid FIA HTP, resp. NHTP.

Category HK1: touring cars, competition touring cars, GT and GTS cars homologated from

1.1.1931 till 31.12.1981, periods D, E, F, G1, G2, H1, H2, I.

HK1 – up to 1150 cm³, up to 1300 cm³, up to 1600 cm³, up to 0 2000 cm³, over 2000 cm³

Category HK2: touring cars, competition touring cars, GT and GTS cars homologated from 1.1.1982 till 31.12.1990 periods J1,J2.

HK2 – up to 1300 cm³, up to 1600 cm³, up to 2000 cm³, over 2000 cm³

Category HK3: 1-seat race cars (formula), 2-seat race cars,

periods C, D, E, F, GR, HR, IR, JR.

HK3 – without cylinder capacity distinction.

3.4.2 Vehicles will be divided up into the following cylinder capacity classes:

NP1 -1400 cm³, NP2 -1600 cm³, NP3 -2000 cm³ (including cars with Diesel engines)

Article 4 - Obligations of Participants

Competition numbers:

The Organiser shall provide each participant with at least two sets of Competition numbers, which must be clearly displayed on both sides of the vehicle throughout the Competition. Vehicles without their correct Competition numbers shall not be allowed to take the start. See Appendix 2 of these Supplementary regulations.

Advertising:

The Organiser has made the following advertising arrangements:

Article 6 - Insurance

In accordance with legal requirements, the Organiser (SAMŠ) has taken insurance policy against the following risks:

- Third Party Insurance up to the amount of € 232 357. This policy is concluded by SAMS and Kooperativa, Vienna Insurance Group a.s., insurance company No. 441-2022429.

This insurance taken out by the SAMŠ is valid for the entire duration of the Competition, not only during official practice and the heats of the race but also for travelling from the parking area to the course of the Competition and back.

Article 7 – Protest and appeals

Protest fee: € 500 (€ 165 for SKP) € 1340 (€ 670 for SKP). Appeal fee set by the ASN:

International appeal fee (FIA): € 6000.

Any protest must be lodged in accordance with the prescriptions of the Code. Protests must be made in writing and given to the clerk of the course or to his assistant, or in their absence to a steward, accompanied by the requisite protest fees.

If the protest requires the dismantling and re-assembly of various parts of a car, the claimant must also pay a deposit which shall be set by the stewards.

Competitors have the right to appeal, as established in Articles 15.1 to 15.4 of the Code and as provided for in the regulations of the International Court of Appeal.

Article 8 – Podium ceremony, Prizes and Awards

8.1 Trophies / Cups

The classifications shall be established and shall entail the distribution by the Organiser of awards as follows:

1st – 3rd place A) MSR: - General Classification

1st – 3rd place 1st – 3rd place - Classifications of the classes - Junior category

1st – 3rd place 1st – 3rd place - General Classification B) MSR HA

- Classifications of the categories

C) GSMP - according GSMP Regulations - point 15.2.

1st - 3rd place D) SKP: General classification 1st – 3rd place - Classifications of the classes

8.2 Record breaking - achieving the absolute best time during race heats which will overcome current track record will be awarded by cup.

8.3

- a) Prizes shall be awarded regardless of the number of Drivers who take the start, in a classes /categories with fewer than 3 starters, only the Driver on 1st place shall receive a Trophy.
- b) All trophies are cumulative and may be combined with one another and with other prizes awarded by the Organisers in the other jointly-organised Competitions.
- c) Awarding of prizes: Trophies are awarded during Podium Ceremony in area of RR Jahodná.

Appendix 1 – Additional provisions by the Organiser

1. Approach of the competing cars to start area

- **1.1** Service park will be placed 3 km after the Finish line (in the area of RR Jahodná) and therefore the organizer will ensure the departure to Start in 2 groups of cars. All drivers must be ready on time for departure to the start area prior the crossroad on driveway to RR Jahodná. Cars are to be ordered in the starting order. Car of the Clerk of the course will approach to Start as last one. No competing car may follow it.
- **1.2** Each race car may be accompanied to Start area with one small service vehicle which will be clearly marked by sticker "START" supplied by the organizer
- **1.3** Drivers must follow safe distance between vehicles, be properly secured by a seat belts while driving to starting area. They can't carry any person in the vehicle or on the bonnet. They must wear a helmet in open vehicles. It is strictly prohibited to overtake or stop on the track. Any infringement will be penalised by COC decision After reaching the starting area, the race and service vehicles will turn and take their posts front of the starting line.
- **1.4** Damaged vehicles may return to the paddock from the track so that they shall slot in between service vehicles on their return to the paddock. Broken-down vehicles will be removed from the track after the end of practice or race heats with the exception authorized by the clerk of the course.
- **1.5** All infringements of these rules will be announced to the Stewards which may decide about penalty.


2. Service park

- 2.1 Service park will be opened on Thursday, 19.5.2016
- 2.2 Service park location: Parking places in area of RR Jahodná, 3 km from Finish
- **2.3** Parking of the trailers inside of the service park is forbidden. They must be placed in the special area reserved by organizer.
- **2.4**The speed of race and service vehicles may not exceed 5 kph in the area of the service park and 30 kph the road to Start area. Every infringement of this rule may be penalised by the Stewards.
- **2.5** Organisers will not provide guard of the service park.

Warning: Arrival in the RR Jahodna will be available only until 06:30 on Saturday 21.05.2016.

Appendix 3 – Slovak Trophy – Historic Regularity Hill Climb (ST HP)

Changes and amendments to the Supplementary regulations

Article 2 – Information specific to the Competition Eligible competitors in ST HP

Drivers must be holders of the following Licences:

- an International or National (without restrictions) Driver's license and Competitor's license issued by SAMŠ
- National Driver's license with restrictions issued by SAMS (it can replace the Competitor's license)
- an International Driver's and Competitor's license issued by the ASN of FIA CEZ country with starting permission for abroad or National licenses issued by FAS AČR.
- daily license issued on Competition (fee 5 €). These drivers must hold a driving license and will be classified only on Competition without points for ST HP series.

Entry fees shall be as follows:

- 260 € (1 race 160 €)

Time for completion of the race track

Time set for completion of the race track will be published in the Bulletin.

Article 3 – Eligible vehicles

All historic vehicles in appropriate categories and periods from 01.01.1931 till 31.12.1990 are eligible in ST HP. Participating vehicles must have a valid HRCP or HTP, NHTP or RLTP passes, which must be presented at the Administrative checks and Scrutineering.

Article 8 – Podium ceremony, Prizes and Awards

ST HP: - General classification: $1^{st} - 3^{rd}$ place
